5.1.3 The institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases.

STUDENT'S GRIEVANCE REDRESSAL CELL

At the starting of the session students' Grievance cell is constituted every year.

The Function of the cell is to look into the complaints lodged by any student and judge its merit. The Grievance cell is also empowered to look into the matter of harassment anyone with a genuine grievance may approach the department members in person, or in consultation with the officer In charge student's grievance cell. In case the person is unwilling to appear in self, a grievance may be dropped in writing at the letterbox/suggestion box of the grievance cell at administrative block. A grievance may also be sent through e-mail to the officer in In charge of the student's grievance cell. The Grievance cell also looks into matters of harassment. Anyone with a genuine grievance may approach the convener or staff in charge of the grievance cell. Grievance also be send through E-Mail convener of the grievance cell.

- To provide the students access to immediate, hassle free recourse to have their grievances redressed.

- To institute a monitoring mechanism to oversee the functioning of the Grievance Redressal Cell Rules.
- To ensure the qualitative as well as quantitative development of the college through students' grievance Redressal cell.

POWERS AND FUNCTIONS OF THE CELL


In case of any grievance the members of the cell are empowered to sort out the problems at their level through discussion with students.

In case the members fail to find out any solution then the matter is referred to the Principal for resolving the matter.

Considering the nature and depth of the grievances due inquiry is made by the members of the cell and through personal discussion the matter is solved.

FUNCTIONS OF THE CELL

- The cases will be attended promptly on receipt of written grievances from the students.
- The committee will review all cases and will prepare statistical reports about the number of cases received.
- The committee will give report to the authority about the cases attended to and the number of pending cases, if any, which require direction and guidance from the higher authorities.
- The committee will send its report with recommendations, if any to the Principal/Secretary of the college and a copy to the aggrieved student within a period of 07 days from the receipt of complaint.
- Procedure of making a grievance registered with Students' Grievance Redressal Cell.
- The students have to place their grievances in the suggestions box/complaint box. The coordinator in turn intimates the matter to the committee for necessary action. Final report based on grievance received and resolved will be submitted to the Principal. The grievance can also be registered by Grievance E.Mail I.D and the Redressal will be initiated within 7 working days.

MECHANISM OF GRIEVANCE CELL



Document the issue/complaint:

The employee should make an initial effort to resolve the grievance with their immediate supervisor. The first step is to write a letter to the grievance redressal Committee/concerned department head/supervisor containing all relevant details of the issue. The supervisor's decision is final unless it is unreasonable, arbitrary, or irrational.

Problem identification:

A supervisor should identify the problem and assess the situation.

Collecting the information:

When the problem has been identified, the supervisor should collect all relevant information about the grievance before developing a plan of action.

Analyse :

To find the root of the problem, the supervisor must study various aspects such as the employee's history, frequency of occurrences and management practices.

Decision making & Implementation:

The management work out several alternative courses of action, and the consequences of each course on the employee and the administration are evaluated. A final decision is reached based on which course of action will benefit all parties concerned and is implemented.

Take Action:


If a grievance refers to a higher authority under this procedure and the outcome does not meet their expectations, both parties can agree to appoint an arbitrator.





Orientation of Awareness program for Grievance Redressal









2. Interactive discussions & question answer sessions were carried out for the student teachers at the end of the lecture.







LECTURE ON GENDER EQUALITY AND WOMEN EMPOWERMENT (2020-21)


The lecture focused on the crucial topics of gender equality and women's empowerment, aiming to create awareness and understanding among the participants.



DIAGRAM OF GRIEVANCE REDRESSAL MACHANISM

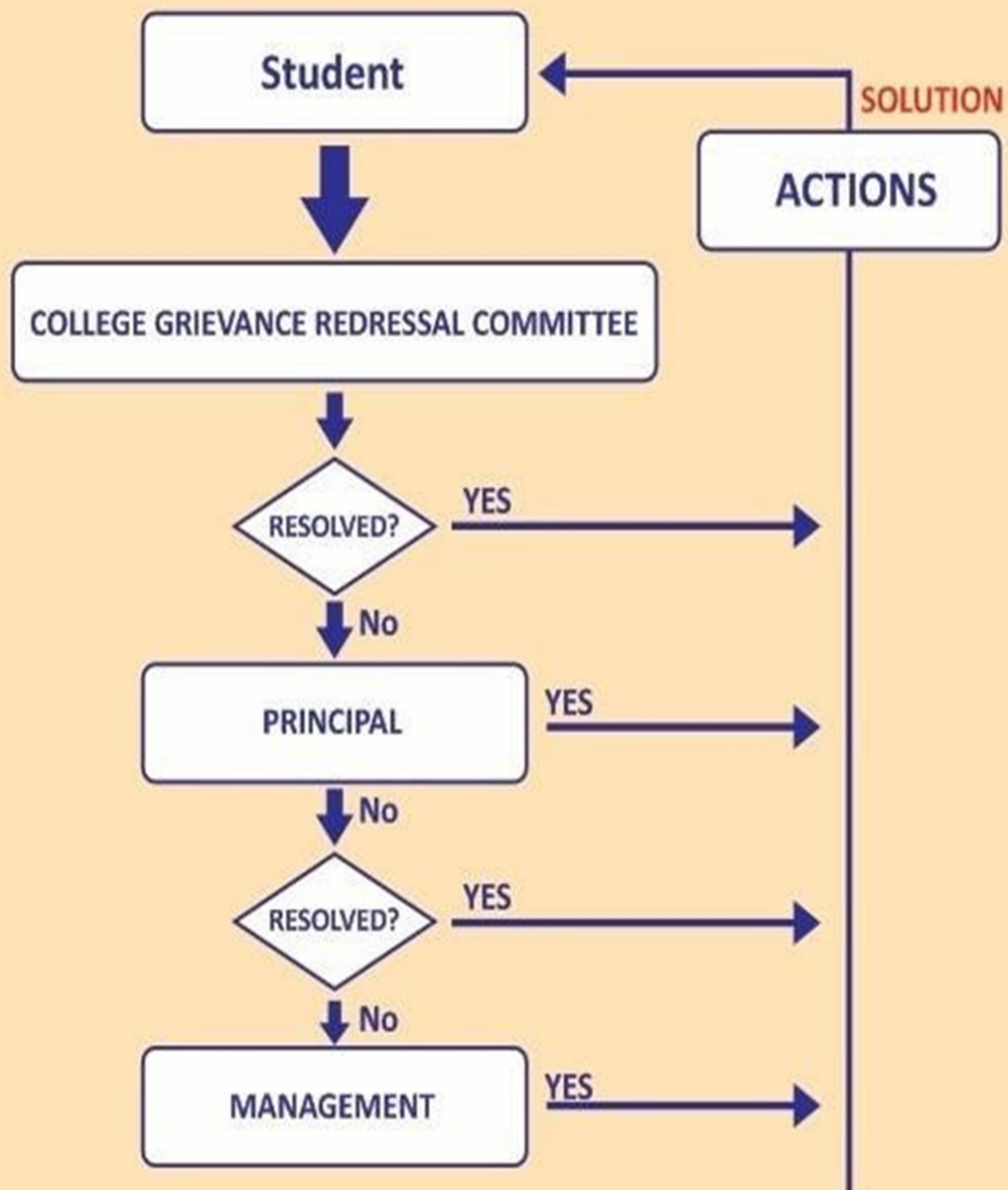



- If the complaint is solved by the Principal then it is fine, otherwise the complaint goes further to the Management committee.



PROCEDURE PERIODICITY AND ATTENDANCE AT MEETINGS

- The Grievance Committee will meet as and when required. However, if necessary, it may meet more frequently at the instance of the Chairman or at the request of the other members to discuss the various issues received.
- At least Five members of the Grievance Committee shall be present in a meeting.
- If a member of the Grievance Committee is connected with the grievance of the aggrieved individual, the concerned member of the Grievance Committee shall not participate in the deliberations regarding that individual's case.
- If the aggrieved person happens to be a member of the Grievance Committee, then she shall not participate in the deliberations as a member of the Committee when her representation is being considered.
